Tianjin, People ' s Republic of China, 10 September 2012 Twenty-six social entrepreneurs have been recognized by the Schwab Foundation as 2012 Social Entrepreneur awardees. Drawn from a pool of more than 1,000 global applicants, the winners are selected in recognition of their innovative approaches and demonstrated impact. Hilde Schwab, Co-Founder and Chairperson of the Schwab Foundation for Social Entrepreneurship, will present the awards during a reception at the World Economic Forum ' s Annual Meeting of New Champions on September 11.

“ Given the complex nature of today ' s challenges, we must find more effective ways to collaborate across sectors, rather than working at cross purposes, ” Hilde Schwab said. “ The 2012 awardees are successfully mobilizing a range of actors, including governments and corporations, to effectively address urgent social and environmental challenges. It is a testament to their impact – and to the efforts of thousands of other social entrepreneurs – that social innovation is becoming a priority for decision-makers at the most senior levels. ”

As a direct result of this award, we deepened our relationships with top CEOs, developed important partnerships, and had major breakthroughs with key institutions such as the National Institute for Health.
