Geneva, Switzerland, 13 March 2013 – Convening under the theme “ Shaping the New Regional Context”, the World Economic Forum on the Middle East and North Africa will be held on 24-26 May 2013 at the Dead Sea, Jordan.

Two years after the start of the transitions in Tunisia and Egypt, decision-makers across the Middle East and North Africa are responding to the challenge of translating the societal momentum into concrete positive outcomes for all citizens. This new context represents a vital opportunity for industry, government and civil society to jointly make historic gains in crucial areas for the region, including youth unemployment, transparency, income disparity, private sector development and infrastructure. At the same time, these efforts are taking place against the backdrop of a deep economic slowdown in Europe and geopolitical uncertainty in the Levant, which underscores the need for enhanced regional cooperation as well as the importance of relations with emerging markets.

The World Economic Forum on the Middle East and North Africa will therefore convene over 1,000 leaders to take a practical look at what policies and business strategies can support the aspirations of the region ’ s economies, while at the same catalysing the dialogue necessary to overcome long-standing fault lines and facilitate a multistakeholder partnership for the future.

“ Building on Jordan ’ s recognized role in the region and internationally, the aim of this year ’ s meeting is to drive the dialogue needed to foster the spirit of multistakeholder partnerships that are so essential for ensuring peace and security at this time of fundamental change, ” said Miroslav Dusek, Director and Head of Middle East and North Africa at the World Economic Forum.
